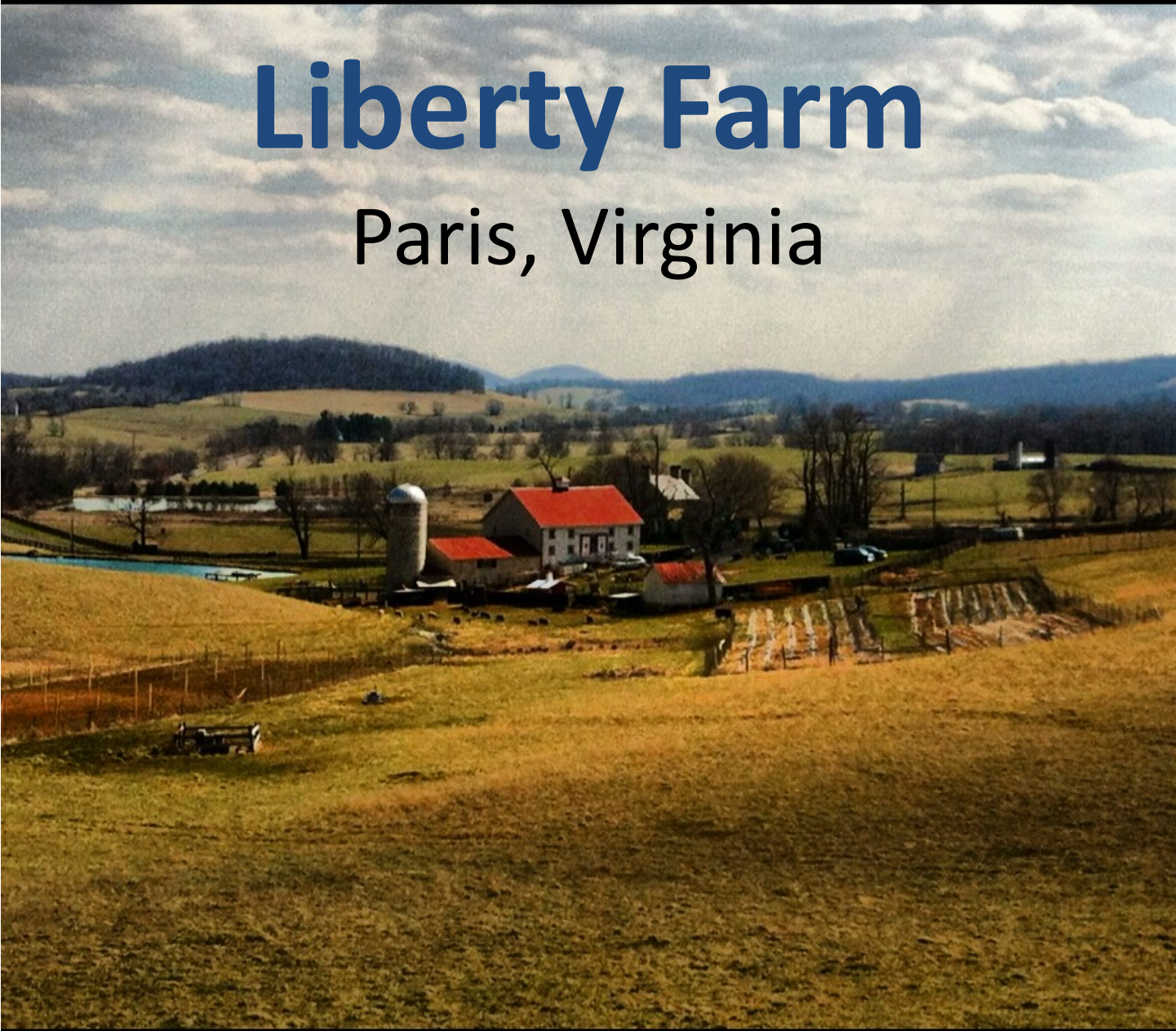

DESCRIPTION OF VIOLATION

You are hereby notified that Fauquier County staff has researched the above referenced property and violation of the following provisions of the Fauquier County Zoning Ordinance:

Code Section	Description of Violation
3-318.21	Operating a farm sales establishment without approval of an administrative permit.
3-308.3 & 3-309.16	Conducting temporary and/or special events on site in conjunction with a farm sales establishment, without approval of a special permit, special exception or site plan.

CORRECTIVE ACTION REQUIRED

Please be advised that you have thirty (30) days to remedy the above violations by ceasing the described above. If you do not comply within 30 days of the date of this letter, these violations will be forwarded to the County Attorney's Office for appropriate legal action, or the County may begin imposing fines, with a maximum fine of up to \$5,000.00 per violation authorized pursuant to Section 13-803.2 of the Fauquier County Zoning Ordinance.

= \$15,000 / per day

The determination by the Zoning Administrator that you are in violation of the Zoning Ordinance is a final decision. If you wish to contest this final decision, you must file an appeal with the Board of Zoning Appeals by submitting a land development application, a filing fee of \$500.00, and the basis for your appeal within thirty days of the date on this notice to the Department of Community Development. Failure to appeal within thirty days will result in your loss of the right to appeal in this matter.



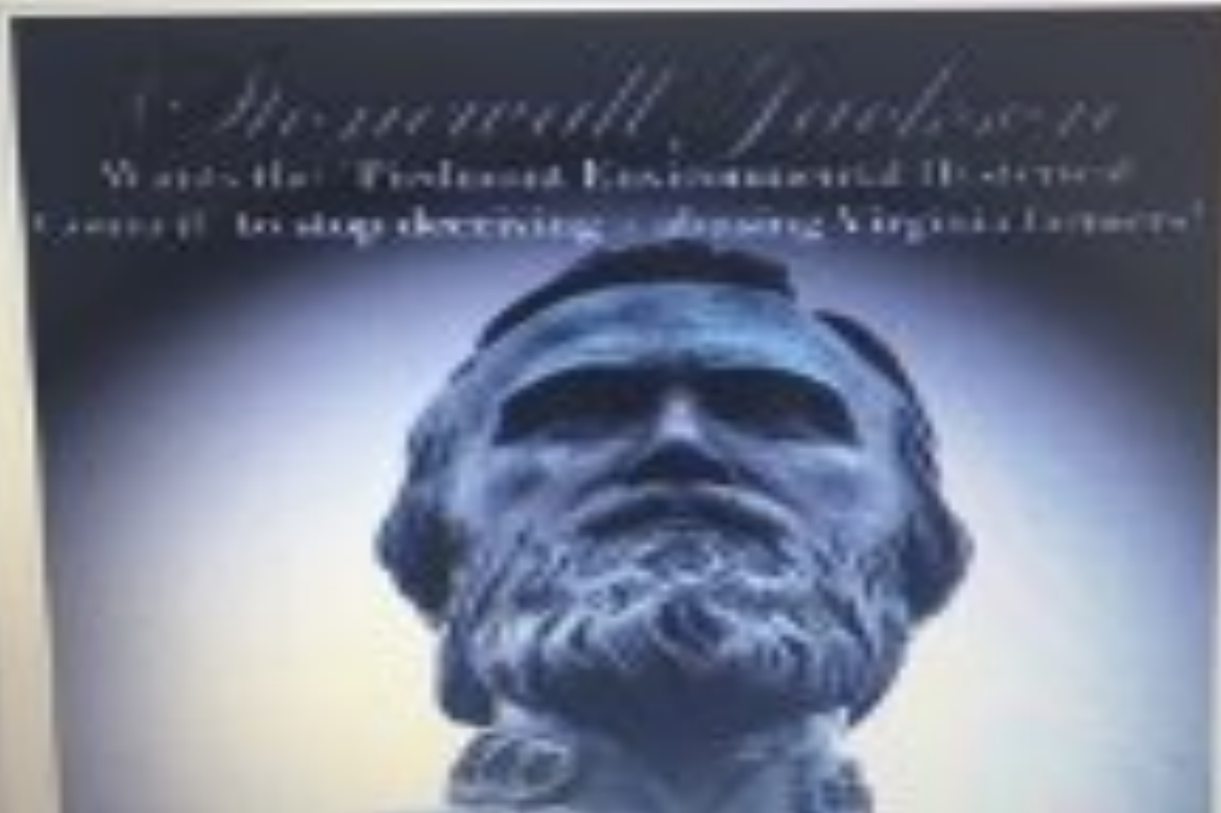

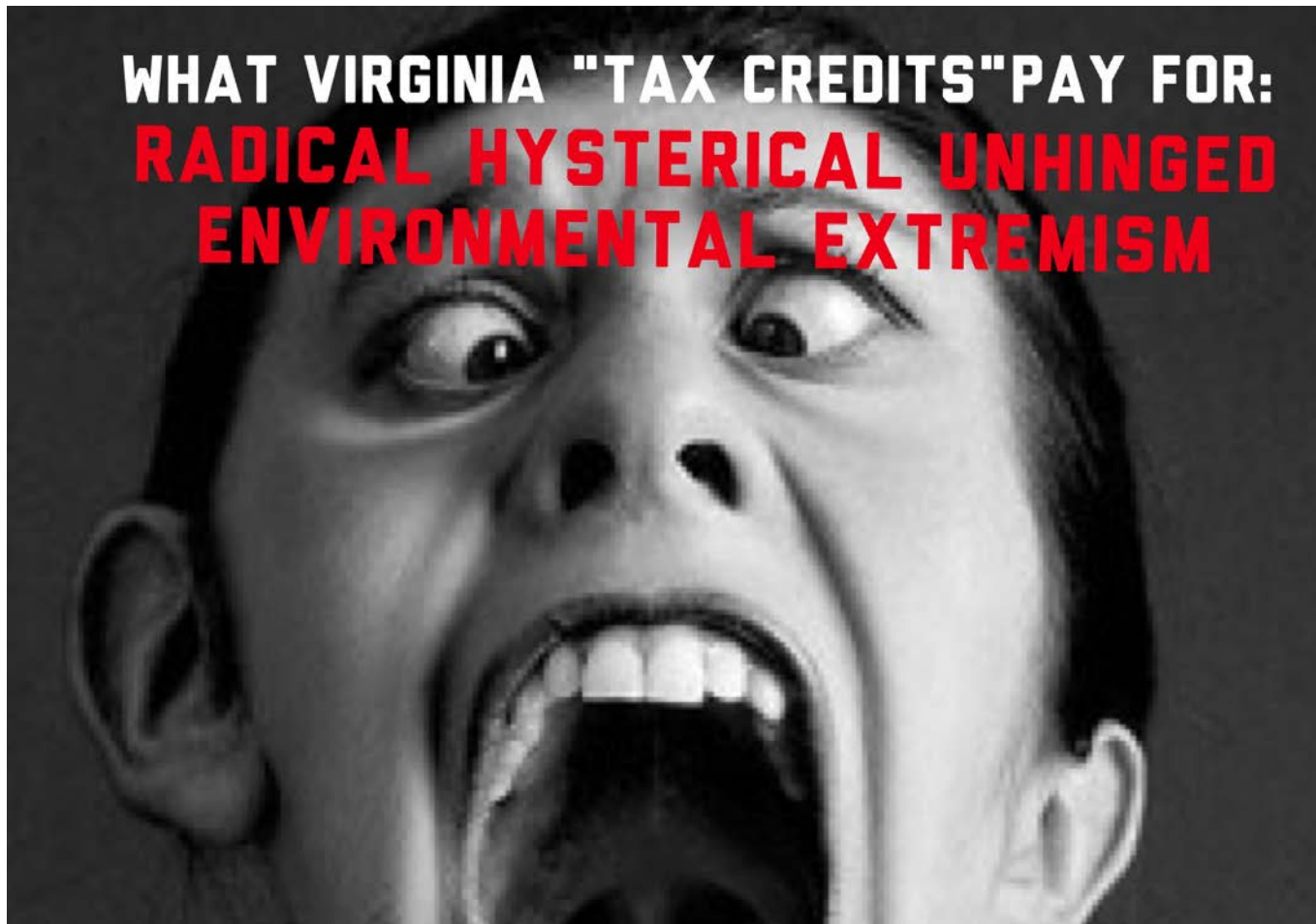
